### AFFIDAVIT & CERTIFICATION

I certify that I meet all of the following eligibility requirements to receive the LIFE Scholarship:

- Must be a legal resident of the State of South Carolina.
- Must have a minimum GPA of 3.0 on a 4.0 scale.
- Must have graduated from high school in South Carolina; or successfully completed a home school program as prescribed by law; or graduated from a preparatory high school outside South Carolina, while a dependent of a parent or guardian who is a legal resident of South Carolina and has custody of that dependent and meets the residency requirements for tuition & fees purposes.
- Must enroll in a degree program as a full-time student.
- Must complete 30 semester credit hours.

I certify that I have not been convicted of any felonies or any second or subsequent alcohol/drug related offenses under the laws of this or any other state or under the laws of the United States. I will use funds from the LIFE Scholarship only for tuition, fees, and other educational costs related to attendance at Florence-Darlington Technical College. I am not in default or owe a refund on any Federal or State of South Carolina educational loan.

For purposes of determining my LIFE Scholarship grade point average (GPA), I certify that I have submitted previous and current official transcript(s) for all South Carolina institutions I have ever attended. I also affirm that if I take courses after signing this document, I will submit any additional transcripts to my home institution. I understand that this information will be used to determine my LIFE Scholarship GPA only and will not be used for my institutional academic standing or for graduation purposes.

I understand that obtaining a LIFE Scholarship by means of willful false statements or failure to reveal any material fact, condition or circumstance affecting my eligibility will be subject to applicable civil or criminal penalties, including the loss of the LIFE Scholarship.

**Please Note:** You MUST be enrolled 12 hours or more **excluding remedial classes** (00 and 100 level) in order to receive LIFE funds. You must complete 30 credit hours and have a cumulative GPA of 3.00 by the end of the school year to continue your LIFE eligibility. Life funds are not disbursed in the summer semester. You may not receive funds for more than eight (8) semesters cumulatively from all schools attended. Students who have been convicted of an alcohol or drug related misdemeanor offense are ineligible only for the next academic year of eligibility after the conviction occurred.
